The 2023 operating budget is increasing by 4.9% over the 2022 budget. The 2 main changes are from the State of New Jersey American Rescue Plan Grant of \$39,000 and the Elizabethtown Gas Grant of \$5,000. These grants have been appropriated and included in the 2023 budget. There are no significant changes to the overall budget from the prior year.

3. **Explain any variances over +/-10% for each line item.** Attach in FAST any supporting documentation that will help to explain the reason for the increase/decrease in the budgeted line item.

There were a few variances from the proposed budget that are in excess of 10% that require additional information or documentation. The main changes were in office expenses, professional fees, repairs & maintenance, materials & supplies which is increased due to purchasing supplies for the office, working with auditors and accountants, the fire trucks are getting older and require additional repairs throughout out the year. There is additional fire equipment and water rescue equipment purchased in order to maintain them in working order. Also, the additional EMS services will be required for the 2023 year. On the other expenses that (-)10% were in administrative wages, training and computers, these will be reduced as they are not recuding the job responsibilites for the admin person, and they are expected to not incur additional monies for training or computer equipment in the upcoming year. As noted above, the additional grants from the State of New Jersey American Resuce Plan and Elizabethtown have been appropriated in the 2023 budget on F-1 and F-3.
