WHEREAS, the Board of Fire Commissioners for the City of Lambertville Fire Department District #1 wishes to accept the above referenced donation of the pumper apparatus to be used by the Fire District for the above states purpose(s), and,

WHEREAS, the Board of Fire Commissioners and its legal counsel has reviewed New Hope Eagle Fire Company and Veolia Water New Jersey, Inc.'s proposal and approves of same.

NOW, THEREFORE, BE IT RESOLVED by the Board of Fire Commissioners of the City of Lambertville Fire Department District #1, County of Hunterdon, State of New Jersey that the Fire District hereby accepts the donation of the 1990 Pierce Lance Top Mount Pumper to assist in the transport of water to cover the areas served by recently affected fire hydrants; and,

BE IT FURTHER RESOLVED that the Fire District hereby authorizes the Chief and Chairman/Vice Chairman to sign and/or execute all necessary documents/agreements to transfer title to the 1990 Pierce Lance Top Mount Pumper to the Fire District.


