**WHEREAS**, in order to effectuate its mandated charge under the aforementioned “Act” And “Code”, the Board of Fire Commissioners of Fire District No. 1, City of Lambertville, County of Hunterdon, State of New Jersey desires to establish the Bureau of Fire Prevention and Code Enforcement within the District which is under the direct supervision and control of the Board and the District Fire Chief.

**NOW, THEREFORE, BE IT RESOLVED**, that the Board of Fire Commissioners of the City of Lambertville Fire Department District #1, County of Hunterdon, State of New Jersey that it hereby establishes the Bureau of Fire Prevention and Code Enforcement, which shall be under the direct supervision and control of the Board of Fire Commissioners and the District Fire Chief; and,

**BE IT FURTHER RESOLVED**, that a copy of this Resolution be forwarded to the New Jersey Department of Community Affairs Division of Fire Safety for its records.
