**RESOLUTION OF THE BOARD OF FIRE COMMISSIONERS AUTHORIZING THE
CREATION OF THE POSITION OF FIRE MARSHAL AND APPOINTING FRANK UR
TO SAID POSITION**

WHEREAS, the Commissioners of Fire District No. 1, Township of Lambertville, County of Hunterdon, State of New Jersey, through the Bureau of Fire Safety under its jurisdiction and control has been designated the local enforcing agency (LEA) pursuant to and in accordance with the Uniform Fire Safety Act (P.L. 1983, C.383; N.J.S.A. 52:27D-192 et seq.) ("Act") and the Uniform Fire Code; N.J.A.C. 5:71-1.1 et seq. ("Code"); and,

WHEREAS, in order to effectuate its mandated charge under the aforementioned "Act" And "Code", the Board of Fire Commissioners of Fire District No. 1, City of Lambertville, County of Hunterdon, State of New Jersey has established the Bureau of Fire Prevention and Code Enforcement within the District which is under the direct supervision and control of the Board and the District Fire Chief; and,

WHEREAS, pursuant to N.J.S.A. 40A:14-81.1 and N.J.S.A. 11A:1-1 et seq., the Board has created the paid position of Fire Marshal; and,

WHEREAS, the Board wishes to appoint Frank Ur to the position of Fire Marshal to be paid via stipend as further agreed upon and recommended by the Fire Chief of the Fire District.

NOW THEREFORE BE IT RESOLVED by the Board of Fire Commissioners of the City of Lambertville Fire Department District #1, County of Hunterdon, State of New Jersey that it hereby appoints Frank Ur as Fire Marshal; and,

BE IT FURTHER RESOLVED, that said appointment shall be effective immediately and shall continue until further action of the Board; and,

BE IT FURTHER RESOLVED, that the duties of the Fire Marshal and the employment responsibilities description shall be developed by the Board after consulting the requirements and the Rules and Regulations promulgated thereunder and as directed from time to time by the Board and/or the Fire Chief of the Fire District; and,

BE IT FURTHER RESOLVED, that a copy of this Resolution be forwarded to the New Jersey Department of Community Affairs Division of Fire Safety for its records.
