**RESOLUTION OF THE BOARD OF FIRE COMMISSIONERS AUTHORIZING THE
BUREAU OF FIRE SAFETY AS THE LOCAL ENFORCING AGENCY (“LEA”)
PURSUANT OF THE UNIFORM FIRE SAFETY ACT AND THE UNIFORM FIRE
CODE LEA WHICH SHALL BE UNDER ITS JURISDICTION AND CONTROL**

WHEREAS, the City of Lambertville has authorized, via ordinance, that pursuant to the Uniform Fire Safety Act, N.J.S.A. 52:27D-192 et seq., the New Jersey Uniform Fire Code, N.J.A.C. 5:70-1.1 et seq., the Local Enforcing Agency (“LEA”) of the New Jersey Uniform Fire Safety Act and the New Jersey Uniform Fire Code shall be Bureau of Fire Safety under the jurisdiction and control of the Lambertville Fire District #1 Board of Fire Commissioners; and, the District Fire Chief; and,

WHEREAS, the Commissioners of Fire District No. 1, Township of Lambertville, County of Hunterdon, State of New Jersey, desire to establish the Bureau of Fire Safety under its jurisdiction and control as the designated LEA pursuant to and in accordance with the Uniform Fire Safety Act (P.L. 1983, C.383; N.J.S.A. 52:27D-192 et seq.) (“Act”) and the Uniform Fire Code: N.J.A.C. 5:71-1.1 et seq. (“Code”).

NOW, THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners of the City of Lambertville Fire Department District #1, County of Hunterdon, State of New Jersey that it hereby establishes that the Bureau of Fire Safety, under its jurisdiction and control, shall be the designated LEA pursuant to and in accordance with the Uniform Fire Safety Act (P.L. 1983, C.383; N.J.S.A. 52:27D-192 et seq.) (“Act”) and the Uniform Fire Code: N.J.A.C. 5:71-1.1 et seq. (“Code”); and,

BE IT FURTHER RESOLVED, that a copy of this Resolution be forwarded to the New Jersey Department of Community Affairs. Division of Fire Safety for its records.
